Subject: Federal Judiciary: Information on Noncase-Related Travel of Article

III Judges in 6 Circuits and 34 Districts

Dear Mr. Chairman:

In March 1997, the Judicial Conference of the United States transmitted to Congress a request for congressional authorization of 12 additional permanent judgeships and 5 temporary judgeships for the United States courts of appeals and for 24 additional permanent judgeships and 12 temporary judgeships for the United States district courts.

On September 24, 1997, you requested that we obtain information on the noncase-related travel of Article III judges² for the period January 1, 1995, through September 30, 1997. Specifically, you requested that we obtain such travel information for judges in the (1) circuit courts of appeals and districts for which the Judicial Conference requested additional judgeships in March 1997, and (2) circuit courts of appeals and districts for which the Judicial Conference did not request judgeships, but which had experienced a judgeship vacancy for 18 months or more as of September 30, 1997. For each noncase-related trip, you asked that we obtain information on the dates of travel, purpose, number of

workdays required, and the organization that paid for the trip. This letter discusses the methodology we used to gather the data and summarizes our results.

SCOPE AND METHODOLOGY

In March 1997, the Judicial Conference sent to Congress a request for additional judgeships in 5 circuit courts of appeals and 23 district courts.³ Later, one of these circuits withdrew its request for an additional judgeship, thus reducing the number of circuits requesting judgeships to four. As of September 30, 1997, these 4 circuits and 23 districts had 63 authorized courts of appeals judgeships and 174.5 authorized district court judgeships. In addition, as of September 30, 1997, 2 circuits and 11 districts had experienced judgeship vacancies of 18 months or more. These additional courts included 27 authorized courts of appeals judgeships and 141 authorized district court judgeships. Thus, we reviewed 6 circuits and 34 districts with a total of 405.5 authorized judgeships.

To determine the number of judges to be surveyed, we subtracted from the authorized judgeship total in each circuit and district (1) the number of judgeships that were vacant as of September 30, 1997, and (2) the number of active⁴ judges who had been confirmed by the Senate after January 1, 1997. We eliminated those judges confirmed after January 1, 1997, because only limited travel data were available from these judges. The Eastern District of Kentucky, which requested an additional judgeship, shares a judgeship with the Western District of Kentucky. Therefore, we also included in our review data from the judge who occupies this shared position. After making these adjustments, we requested data on noncase-related travel of 337 active judges—68 active courts of appeals judges and 269 active district court judges (see enc. I).

Through the Administrative Office of the U.S. Courts (AOUSC), we asked each of these 337 judges to identify the travel dates, purpose, destination, and paying organization for each noncase-related trip they took during the period January 1, 1995, through September 30, 1997. We defined noncase-related trips as trips not directly related to adjudicating cases. We excluded trips, such as vacations, that were paid from judges' personal funds.

The judges sent their data both to us and to AOUSC. Generally, each circuit and district sent a single report that included data separately for each judge in the circuit or district. We received data from a total of 6 circuits and 34 districts (see table in enclosure I). Altogether, these 6 circuits currently have 90 authorized judgeships, with 68 active judges

and 22 judgeship vacancies. We received data from 64 of the 68 active judges in these circuits. The 34 districts reporting data have a total of 315.5 authorized judgeships, with 269 active judges and 47 judgeship vacancies.⁵ We received data from 254 of the 269 active judges in these districts.

Many of the reported trips were for similar purposes, such as training. To make it easier to compare the number of trips for a similar purpose, we organized the reported trips into five categories: (1) judicial meetings and activities within the district or circuit;⁶ (2) workshops, seminars, and other activities sponsored by AOUSC or the Federal Judicial Center (FJC); (3) meetings and conferences pertaining to courthouse construction; (4) Judicial Conference activities;⁷ and (5) other.⁸ In categorizing trips, we included in a single category all trips to circuit or district conferences, whether the trips were within or outside the reporting judge's own circuit or districts. We also included in the category, "Judicial Conference activities" five trips to the Council of Judicial Associations.

We used the dates of the reported travel for each trip to determine the length of each trip because travel dates were the only comparable data each reporting judge provided on the length of each trip. We counted all travel days as whole days except where a judge specifically reported that a trip included a half day of travel. In those instances, we counted one of the travel days as a half day. When a judge reported that a trip had an evening departure, we reduced the travel days for the trip by one since the departure was after business hours. In some cases judges reported trips with overlapping dates. For example, the return date for one trip was the same as the departing date for the succeeding trip. In such cases, we eliminated the duplicate dates from our count of travel days. Judges reported a few trips in which the travel began in September 1997 and

was completed in October 1997. For such trips, we counted only the travel days through September 30, 1997, the end of the period for which we collected travel data. We then identified workdays by excluding weekend days and federal holidays during the period January 1, 1995, through September 30, 1997.

We did not independently verify the reported data on the number of trips taken, the dates of travel for each trip, the purpose of each trip, the destination, or the paying organization. Where there were questions about the information reported, we worked with officials from AOUSC and the respective circuits and districts to resolve them.

Throughout this assignment, we consulted with AOUSC officials and worked closely with them to address any unresolved issues. On February 17, 1998, we requested comments on a draft of this letter from the Director of AOUSC. On February 25, 1998, AOUSC's Program Assessment Officer provided oral comments, indicating that he generally agreed with the report. He also provided technical corrections, which we incorporated into the report, where appropriate.

We performed our work principally in Washington, D.C., and Dallas, TX, from September 1997 through February 1998 in accordance with generally accepted government auditing standards.

SUMMARY OF DATA

Courts of Appeals Judges

The 64 circuit courts of appeals judges who responded to our request for travel data reported that they took a total of 1,463 noncase-related trips encompassing 3,220 workdays during the period January 1, 1995, through September 30, 1997 (see table 1). Together, circuit meetings and activities; AOUSC- or FJC-sponsored workshops, seminars, and other activities; trips associated with courthouse construction and renovation; and Judicial Conference meetings and activities accounted for about 68 percent of all trips and about 73 percent of all travel workdays reported during this period. The federal judiciary paid for all the trips in these four categories. During calendar year 1995, these same four categories of noncase-related trips accounted for 70 percent of all trips and about 74 percent of all travel workdays reported for these 64 courts of appeals judges. Comparable figures for calendar year 1996 were 63 percent and 69 percent, respectively. Comparable figures for 1997 (through September 30) were 73 percent and 76 percent, respectively (see table 1 below). Further information on the number of trips and workdays spent on travel, by major category, is provided in enclosure II.

As shown in table 2 below, there was a noticeable difference between the circuits with the highest and lowest average number of noncase-related trips per judge and between the circuits with the highest and lowest average number of workdays per judge spent on noncase-related travel.

The total number of trips reported varied among the circuits, and among judges within the same circuit, for several reasons. First, in some circuits, judges served on Judicial Conference committees or subcommittees and traveled to meetings of these committees and subcommittees—travel not required of their colleagues who did not serve on such committees. Second, some judges were involved in courthouse construction committees that required a number of trips to meet with architects and officials with the General Services Administration (GSA). Third, some judges were active in local and national bar associations and related organizations and traveled to more events sponsored by these organizations than did their colleagues within the circuit or judges in other circuits who attended such events. Fourth, judges in geographically large circuits, such as the Ninth, may travel more to committee or administrative meetings in locations throughout the circuit.

The destinations visited by the circuit courts of appeals judges also varied widely–from local bar association meetings to trips overseas to teach seminars. About 98 percent (1,434) of the 1,463 noncase-related trips taken by the circuit court judges during the period January 1, 1995, through September 30, 1997, were for destinations within the United States. Fourteen circuit courts of appeals judges reported a total of 29 trips to other nations. Enclosure IV provides information on trip destinations, and enclosure V contains information on the organizations that paid for the reported trips.

¹⁰We did not count trips to destinations in the Commonwealth of Puerto Rico or the U.S. territories of Guam, the Northern Mariana Islands, and the Virgin Islands as overseas or foreign travel because these destinations are the locations of U.S. district courts.

District Court Judges

The 254 district court judges who responded to our request for travel data reported that they took a total of 3,741 noncase-related trips encompassing 9,832 workdays during the period January 1, 1995, through September 30, 1997 (see table 3). Together, circuit meetings and activities; Judicial Conference meetings and activities; AOUSC- or FJC-sponsored workshops, seminars, and other activities; trips associated with courthouse construction and renovation; and Judicial Conference meetings and activities accounted for about 86 percent of all trips and about 87 percent of all travel workdays reported during this period. The federal judiciary paid for all the trips in these four categories. During calendar year 1995, these same four categories of noncase-related trips accounted for 87 percent of all trips and about 89 percent of all travel workdays for these 254 district court judges. Comparable figures for calendar year 1996 were 84 percent and 84 percent, respectively. Comparable figures for 1997 (through September 30) were 87 percent and 88 percent, respectively (see table 3 below). Enclosure VI provides further information on the number of trips and workdays spent on travel, by major category.

As with the circuit court travel data, there was a noticeable difference between the districts with the highest and lowest average number of noncase-related trips per judge and between the districts with the highest and lowest average number of workdays per judge spent on noncase-related travel (see table 4).

As with the circuit court judges, the total number of trips reported by district court judges varied among the districts, and among judges within the same district, for several reasons. First, in some districts, judges served on Judicial Conference committees or subcommittees and traveled to meetings of these committees and subcommittees—travel not required of their colleagues who did not serve on such committees. Second, some districts had newly appointed judges who attended one or more sessions of new judge orientation and training. Third, some judges were involved in courthouse construction committees that required a number of trips to meet with architects and GSA officials. Fourth, some judges were active in local and national bar associations and related organizations and traveled to more events sponsored by these organizations than did their colleagues within the district or judges in other districts who attended such events.

The destinations visited by the district court judges also varied widely–from local bar association meetings to trips overseas to teach seminars. Nearly 99 percent (3,695) of the 3,741 noncase-related trips taken by the district court judges during the period January 1, 1995, through September 30, 1997, were for destinations within the United States. ¹¹ Thirty

¹¹We did not count trips to destinations in the Commonwealth of Puerto Rico or the U.S. territories of Guam, the Northern Mariana Islands, and the Virgin Islands as overseas or foreign travel because these destinations are the locations of U.S. district courts.

district court judges reported a total of 48 trips to other nations. ¹² Enclosure VIII provides information on trip destinations, and enclosure IX contains information on the organizations that paid for the reported trips.

As agreed with your office, we plan no further distribution of this letter for 15 days, unless its contents are made public. At that time, we will send copies to the Ranking Minority Member of your Subcommittee; the Chairman and Ranking Minority Member of the Subcommittee on Commercial and Administrative Law, House Committee on the Judiciary; the Chairman and Ranking Minority Members of the House and Senate Committees on the Judiciary; the Director of the Administrative Office of the U.S. Courts; the Director of the Federal Judicial Center; the Chief Judge of each of the 6 circuit courts that provided data; and the Chief Judge of each of the 34 district courts that provided data.
